

BAINBRIDGE DISPOSAL INC. DROP BOX AGREEMENT

*We ask that you use the drop box (10-yard / 30-yard / 40-yard) within one week's time
-or-
If you need it for an extended period of time, to have it dumped once weekly.*

CHARGES:

Prepayment

Unless you're a regular commercial customer, we will require prepayment in the following amount for each drop box along with a complete and signed copy of this release form prior to delivery.

1. 10-yarder \$461.54
2. 30- or 40-yarder \$600.00
3. If more is owed, we will require the balance be paid in full before we haul anymore loads. Overpayments will be refunded.

Collection Charges

1. 10-yarder \$425.00 (flat fee) Dimensions approximately 5' high 7' wide 10' long (no boards or partitions of walls over 5ft high or 6ft long)
2. 30-yarder \$435.40 plus \$71.00 / ton (delivery & 1st pick-up) Dimensions approximately 6' high 7' wide 22' long
3. 40-yarder \$458.28 plus \$71.00 / ton (delivery & 1st pick-up) Dimensions approximately 7' high 7' wide 24' long
4. Any material that can't fit in compactor opening will be considered **Bulky Wastes** (compactor opening is 5' wide x 8' long x 2' high) which is charged at a rate of \$100.86 per ton.

Return Charges

1. A return trip to re-position the drop box (any size) is \$40.00.
2. A return trip to re-locate the drop box to another address is \$87.27 for a 10-yarder and \$124.70 for a 30- or \$130.93 for a 40-yarder.
3. An hourly time charge will be added if driver has to clean up, rearrange the load or wait for vehicles to be moved or access to the drop box otherwise made available.

*The above amounts **do not** include 3.6% State Refuse Tax and 5% City Utility Tax.*

RESTRICTIONS:

DO NOT ATTEMPT TO MOVE THE BOX WITH YOUR OWN EQUIPMENT.

Do not fill above the **top** of the box.

ABSOLUTELY NO CONCRETE or CREOSOTE.

Any concrete or creosote found in your load will cause the entire load to be returned to your site.

Additionally, no **paint products** or other **hazardous waste**, no **computer monitors, televisions.**

No automobile parts (except tires which will be charged at a minimum of \$5.00 per tire).

Any of these items found in your load will be returned to your site.

All **appliances** will be added to your bill at **\$50.00** per appliance.

If you plan on loading a composition roof (3-tab) or other heavy materials, please let us know before-hand.
(10-yard drop boxes are moved with a smaller truck which can't lift heavy loads.)

RELEASE AND PERSONAL GUARANTEE:

Bainbridge Disposal, Inc. is not responsible for any damage to roadways, driveways, brush, shrubs, trees, or any other existing site improvements. Customer hereby agrees to release, indemnify and forever hold harmless Bainbridge Disposal, Inc., its employees, officers and agents, from all responsibility and liability, including attorneys' fees, with respect to any and all claims for personal injury or property damage arising from drop box services.

Customer agrees to pay all costs associated with collecting amounts due to Bainbridge Disposal, Inc. for services rendered under this Drop Box Agreement, including attorneys' fees, in the event that the account becomes delinquent.

At the discretion of Bainbridge Disposal, Inc., a personal guarantee of payment may be required for services under this Drop Box Agreement. For good and valuable consideration, receipt of which is acknowledged, for the benefit of, and to obtain trade credit for Customer, the undersigned Guarantor hereby personally guarantees, on a joint and several basis along with any other guarantors of the obligations guaranteed herein, the performance of all obligations of Customer including, but not limited to, payment of all present and future indebtedness of Customer to Bainbridge Disposal, Inc., whether secured or unsecured and regardless of how the indebtedness is incurred and regardless of prior notice, demand or pursuit of remedies against Customer. This Personal Guarantee shall continue in effect until such time, if ever, as Guarantor has delivered written notice of the termination of this Personal Guarantee; provided, however, that any such termination shall not alter any obligation of Guarantor arising hereunder prior to receipt of such written notice.
